Council is seeking Expression of Interest for approximately 68 hectares of Land at the Condobolin Airport.

DESCRIPTION

Lachlan shire council is renting:

Part Lot 12 DP 1077845 and Lot 3 DP 530410 in Condobolin. The block consists of approximately 68.1 hectares of farming land.

The lot is fenced and the applicant would be required to maintain the fences in a stock proof condition and will at all times ensure that any stock on the land are prevented from straying onto the adjoining Condobolin Aerodrome. The property is rented in an "as in where is condition" and all prospective applicants will be required to satisfy themselves the property is suited to their needs.

The property cannot be sub-let to another party.

The property licence cannot be transferred to another party. If you wish to vacate the property, you need to give notice to Council.

Cannot be used for horses, pigs, goats, cattle or to keep other domestic animals. The Licence Agreement will have a 3-year term.

EXPRESSION OF INTEREST

Following a rental appraisal from a local independent Agency, the rent has been determined as follow:

Offers above \$200 per week inclusive of GST with an annual CPI Increase.

Payment will be 12 months in advance.

The Lessee will pay the costs of legal expenses.

BOND

Council will require a bond equivalent to 4 weeks rent to be paid upon signing of the license agreement. The bond is refundable at the end of the licence so long as the property is left in the same condition as when the licence started.
